



CEMATRIX Announces \$6.2 Million in New Contracts

Calgary, Alberta – October 24, 2024 – CEMATRIX Corporation (TSX: CEMX) (OTCQB: CTXXF) ("CEMATRIX" or the "Company") a North American leading manufacturer and supplier of technologically advanced cellular concrete products today announced that it has executed \$6.2 million in new contracts since the company's last announcement on July 10, 2024. Factoring in the \$6.2 million in new contracts, total contracts executed in 2024 is \$42.0 million.

"The \$6.2 million of new contracts are composed of various projects across North America, none of which are in excess of \$1 million. Most of the additional \$6.2 million in new contracts are scheduled to be completed in 2024," stated Jeff Kendrick, CEMATRIX President and CEO. "With the addition of these new contracts net of sales to the end of September, our current backlog now stands at \$74.7 million."

The Corporation's Backlog is defined as Contracted plus Contracts in Process net of sales completed to date. Contracts in Process are defined as projects where the related contract is in office for review or signature; or signed and returned to the client for their signature; or is in the post award project submission process; or is awarded by letter of intent; or is awarded by some other form of written communication.
